ORDER:

1. Government have decided to give an opportunity of providing a Laptop Computer to the new Ministers in the new Government on 50% grant and 50% loan basis in continuation of the scheme started during the year 1997. For the year 2000-2001 also, Government have sanctioned a grant of Rs.7.5 Lakhs as Government support (Grant) and Rs.7.5 lakhs towards loan for the purchase of Laptop Computers for 2000-2001 for 10 new Ministers newly sworn-in in the New Government in the year 1999 in pursuance of U.O. Note read above issued by Fin. (A&L) Department.

2. The above amount was exhausted for 10 ministers as per G.O. 5th read above. Further Government have decided to extend this facility for other Ministers also those who have not availed this facility so far. Government hereby sanction a grant of Rs. 3 lakhs as Government support and Rs.3 lakhs as loan for the purchase of Laptop Computers for 2000-2001 as second time.

3. The expenditure sanctioned in para 2 above shall be debited to the following Head of Account:

4. The above expenditure sanctioned towards grant shall be met by reappropriation of funds from the existing provision under:

5. A provision of Rs.18.75 lakhs (Rupees eighteen lakhs and seventy five thousand only) being the loan component of the Laptop Computer advance to Ministers is released by Finance Department vide U.O. Note cited to the G.A. (Poll.C) Departments for the 1st quarter 2000-2001 for sanction of the loan to eligible applicants as per Rules.

6. The Finance & Planning (Fin. CCS.II) Department is authorized to draw the amounts based on the individual orders issued by General Administration (Poll.C) Department and the D.C. Bills should be submitted by Finance & Planning (Fin.CCS.II) Dept., within one month from the date of drawal of advance.
