ORDER:

Government of Andhra Pradesh, in the reference fourth read above notified M/s. Baan IT Park India Pvt. Ltd. as an IT Park eligible for the incentives under para 11 (i) of the G.O. first read above. APIIC Ltd. in the reference fifth read above pointed out that M/s. Baan IT Park India Pvt. Ltd. actually established itself in Plot no. 17 and the adjoining area of 14.39 acres in Phase II of Software Layout Units, Madhapur whereas as per the orders in the reference fourth read above, it is indicated only as Plot no. 17 of Software Layout Units. APIIC also informed that M/s. Baan IT Park India Pvt. Ltd. operationalised in November 1999 itself and therefore eligible for 90% of the rebate. Further it was informed that the name of M/s. Baan IT Park India Pvt. Ltd. has been changed as M/s. Vanenburg IT Park Pvt. Ltd. and the same was approved by APIIC Ltd. vide their letter dated 07.09.2000. In view of the above, APIIC Ltd. requested to issue an amendment to the orders in the reference fourth read above.

2. Government after careful consideration hereby issue the following amendments to the orders contained in the G.O. fourth read above.

Amendment

- i. “M/s. Baan IT Park India Ltd.” wherever it occurs in the Notification issued shall be read as “M/s. Vanenburg IT Park Pvt. Ltd.”
- ii. The first paragraph of the above notifications containing the text “Plot no. 17 of Software Units Layout, Madhapur, Ranga Reddy Dist., located as an IT Park subject to the conditions stipulated there in” shall be read as “Plot no. 17 of 5 acres and the adjoining plot of 14.39 acres in Phase II of the Software Units layout, Madhapur, Ranga Reddy Dist. notified as an IT Park as per Government orders first read above under para 11 (i) read with the sub-clauses therein subject to the following:”

iii. Vanenburg IT Park Pvt. Ltd, reported in their application for IT incentives that the commencement of commercial operations as 1.12.1999. They are therefore eligible for 90% concession.

3. This order does not require the concurrence of Finance and Planning (Fin. Wing) Department, as this is only an amendment to the orders issued earlier.
