ORDER:

Orders have been issued vide references 3rd and 4th cited nominating 22 officers to undergo the CIO training at IIM, Ahmedabad from 5th February 2007. Mr. D. V. Ramanamurthy, Deputy Director, Social Welfare, Kakinada at Sl. No. 19 of the selected list (vide reference 3rd cited) expressed his inability to attend the programme with this batch due to work exigencies. 5 seats were reserved for Limpopo provincial Govt. and one officer could not reach India in time; This slot is now released to be filled up by GoAP officer.

2. In view of the above – the Commissioner Social Welfare was requested to send in a suitable replacement. Accordingly Mr. Caleb, Dy. Director (SW) has been nominated by the Commissioner. Sri.Caleb, DD (Hostels & Gazetted Estt and Computers) O/o Commissioner Social Welfare, Hyderabad and Mr. Prasad Dy. EE O/o CE Inter State & Water Resources are hereby selected for the 7th Batch of AP CIOs training to be conducted from 5th February 2007 to 21st April 2007.

3. The travelling arrangements for the selected officers have to be made by the departments concerned and the departments shall sanction the D.A. in advance to the officers as per the existing rules on request of the officers.

4. The above officers are requested to attend the training programme from 05-02-2007 to 18-02-2007 at Indian Institute of Management, Ahmedabad and from 20-02-2007 to 21-04-2007 at Dr. MCR HRD Institute of Andhra Pradesh, Hyderabad. He shall leave for Ahmedabad on 5th February 2007 evening.

5. They are also required to execute a bond to continue to serve the Government of Andhra Pradesh for a period of 2 years after completion of this training programme and to be the chief information officers for the respective departments.


