ORDER:

In the order 1st read above Government have extended the exemption of payment of 5% of transfer of property duty coming under the municipal limits of Serilingampally involving transfer of land from Software Technology Park, Hyderabad to Andhra Pradesh Industrial Infrastructure Corporation Limited or subsequent transfer from the joint venture company to others involving either land or built up area. This exemption extended resulted in many international Information Technology Companies to base their companies, also to establish new ventures in Andhra Pradesh, thus providing vibrant Information Technology (IT) growth in the state. incentives were extended for a period of 5 years from 21.3.1997 to Due to global economic slow down the performance of IT Industry has effected which in turn effected the growth and investments in the State and in order to attract new IT Companies, to retain the existing IT Companies and to continuously make the Hi-tech City the most attractive destination, it has been proposed to consider the exemption of 5% of transfer of property duty for a further period of 3 years ie., 21.3.2002 to 20.3.2005.

- 2. Government after careful consideration extend the exempt from payment of 5% of transfer of property duty coming under the municipal limits of Serilingampally involving transfer of land from Software Technology Park, Hyderabad to Andhra Pradesh Industrial Infrastructure Corporation Limited or subsequent transfer from the joint venture company to others involving either land or built up area.
- 3. The above said exemption shall be applicable to all the transactions of transfer of land / lease / lease-cum-sale built-up area for setting up of IT based projects and other common purpose infrastructure and financial services related to such projects in the INFOCITY /STPH and not for other commercial purposes such as dwelling / commercial units.
- 4. This exemption shall be in force for a period of (3) years with effect from 21.3.2002 to 20.3.2005.
