ORDER:

Government of Andhra Pradesh has launched its official portal <http://www.aponline.gov.in> on 23rd March, 2002 with a view to provide an electronic gateway to the portfolio of Government services on Internet. AP Portal is developed and managed by "M/s APONLINE LIMITED" a Joint Venture of Government of Andhra Pradesh and TATA Consultancy Services Limited. With a view to enable the people of Andhra Pradesh and the Government departments to utilize the services of APONLINE LIMITED, in a speedy and convenient manner, Government has also proposed to implement citizen services on AP Online enabling citizens to pay bills through internet with the use of credit card. The following decisions were taken by the Government in view of the facility to be implemented.

2. APOnline Limited has verified internet Credit Usage Charges and EDC Machine Charges with various banks. Finally Citibank and ICICI Bank have come forward with their proposals to provide Electronic Payment Gateway Services for users of APOnline Government Portal.

3. The Government after careful consideration and detailed examination hereby orders as follows:

- i. ICICI Bank to be the Merchant Banker and will facilitate transaction at the following rates:
 - a. On the net Credit usage charges 1.80% of the bill value
 - b. On the EDC Machine usage 1.75% of the bill value

- ii. APTS to open current account (including sub accounts), on behalf of Government of AP, with ICICI Bank
 - iii. IT &C Department shall sign an agreement with ICICI Bank, on behalf of the Government of Andhra Pradesh.
4. APOne Limited will facilitate the payment gateway with ICICI Bank through the website www.aponline.gov.in
