ORDER:

In the G.O. first read above, certain incentives were sanctioned to I.T. Industries and I.T. enabled services in the State.

2. In the G.O. second read above, an amendment to the G.O. first read above was issued extending the same concessions to the Companies establishing telecommunication infrastructure with a view to providing broadband connectivity for setting up convergence facilities enroute for laying optical fibre cable.

3. In the letter third read above, M/s. Reliance Infocom Limited, Hyderabad have requested for 100% exemption of Stamp Duty and Registration Fee on purchase and lease of land and buildings as against the existing rates of exemptions available.

4. After careful examination of the above matter, Government have decided to allow 100% exemption of Stamp Duty and Registration Fee on purchase and lease of land and buildings in favour of M/s. Reliance Infocom Limited. In respect of extending similar facilities to all special category cases, such cases will be examined separately.

5. Accordingly, the following notifications will be published in next issue of Andhra Pradesh Gazette.

NOTIFICATION – I

In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamps Act, 1899 (Central Act II of 1899), the Governor of Andhra Pradesh hereby exempt the Stamp Duty by 100% on purchase and lease of land and buildings in favour of M/s. Reliance Infocom Limited, Hyderabad for the facilities established before 31.3.2002.

NOTIFICATION – II

In exercise of the powers conferred under section 76 of the Registration Act, 1908 (Central Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Table of Fees issued in G.O. Ms. No. 1637, Revenue Department, Dated 3<sup>rd</sup> September, 1958 and published at pages 2290 to 2295 of Part I of the Andhra Pradesh Gazette Dated 11.9.1958 as subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" in Article I(a), after clause "K(XCXXVI)", the following clause shall be added, namely:

"K(XCXXVII) : The Registration Fee leviable under this Article on the purchase and lease of land and buildings in favour of M/s. Reliance Infocom Limited, Hyderabad shall be exempted by 100%, for the facilities established before 31.3.2002."
