ORDER:

In the G.O. 1st read above orders were issued by the Revenue Department for exemption of Stamp Duty by 100% on purchase and lease of land and buildings in favour of M/s. Reliance Infocom Ltd.

2. In the Reference 2nd read above M/s. Reliance Infocom Ltd., Hyderabad have requested for 6 concessions treating the same as “Mega Project” of laying optical fibre cable. It was also requested for 100% exemption of Transfer Duty on purchase and lease of land and buildings as against the existing rates of exemption available.

3. Government after careful consideration of the matter and in exercise of the powers conferred under Section 69 (5) of Andhra Pradesh Panchayat Raj Act, 1994 hereby exempt the M/s. Reliance Infocom Ltd., Hyderabad from payment of Transfer Duty from 19.2.2001 by 100% on purchase and lease of land and buildings in favour of M/s. reliance Infocom Ltd., for their Mega Project to be completed before 31.3.2002.
